



## **INDEPENDENT CONTRACTOR-PEER REVIEWER ADDENDUM**

This addendum (“Addendum”) to the Independent Contractor-Peer Reviewer Agreement (the “Agreement”) is made and entered into as of [EFFECTIVE DATE] (the “Effective Date”), by and between [PHYSICIAN’S NAME], (“Physician”) and Dane Street, LLC (hereinafter “Dane Street”) on behalf of itself and its affiliates (collectively, “Dane Street”; the parties will collectively be the “Parties”). **NOW, THEREFORE**, in consideration of the foregoing, the mutual covenants and agreements set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:
